You must submit a signed statement of the dog's condition from your veterinarian on his/her office stationery along with your request for such a refund to the trial secretary at least 30 minutes before the start of the trial.

**No refunds** for errors on entry forms, or if a dog is absent, disqualified or excused. No refunds if the show cannot open or be completed by reason of riots, civil disturbances, fire, extreme and/or dangerous weather conditions, an Act of God, public emergency, act of a public enemy, strikes or any other cause beyond the control of the club.

**Dogs may arrive any time prior to their scheduled time of judging. Dogs not required for further judging will be excused.**

**Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the judging ring when their classes are called to be judged.**

- A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his name.
